#### 6. CLERK'S REPORT & CORRESPONDENCE TO NOTE

The church submitted an enquiry asking to place a nativity scene at Hellmans Cross on parish council land. Guidance was obtained from Essex Highways and forwarded to the church. The request was withdrawn due to the limited timescales and will be considered further in 2023.

The Pagentmaster has issued guidance re beacon lighting confirming national beacons will not be lit for the King's Coronation. The reason being, the palace are conscious that the Coronation will take place less that a year after The Queen's Platinum Jubilee Beacons were lit, and are therefore anxious to ensure that the events planned for May 2023 have a markedly different look to those of June 2022.
